Motor Carrier Registration functions

The Motor Carrier Registration system, a part of the **PUCO Community**, is where the transportation registration users can do the following:

- 1. Motor carriers or third-party agents submit new, renewal or amended intrastate registration applications
- 2. Insurance companies and managing general agents add, edit and cancel insurance information and insurance companies establish or remove relationships with managing general agents
- 3. Transportation network companies or third-party agents file new, renewal or amended TNC registration applications

New account sign-up form

1. Navigate to puco.ohio.gov, click Transportation, then Motor carrier registration system.



2. The Motor carrier registration system webpage displays. Click Create new motor carrier registration account.

Only direct employees of motor carriers or insurance providers (insurance companies) can complete the new user sign-up form. Because of the unique relationships and records that must be set up in the back-end system, managing general agents, third party agents/brokers and transportation network companies must call Motor Carrier Registration at (800) 686-8277 or email <u>MCRegistration@puco.ohio.gov</u> to request a new account.

4. Search for your company. Motor carriers will search by USDOT Number and insurance companies will search by NAIC number. The steps and screens are the same for both types of companies.

Enter the **USDOT Number** or **NAIC number** for your company. Click **Search**.
